### A NOTE FROM THE PRESIDENT

At our March meeting, we will be voting on a sustainability statement to the County Board, which I fully expect to pass. You can read it on our website at aurorahighlands.org.

**Engagement** is the focus of the Aurora Highland Civic Association. Regarding Amazon, our county government, educators, businesses, and developers scored a much better deal than New York did. Nonetheless, I hope with the passage of the sustainability statement we can impress on the County Board the importance of long-range holistic and collaborative planning. JGB has a plan, the Crystal City BID has a plan, the universities have a plan. The County has several plans that guide development in Pentagon City and Crystal City, as well as numerous separate plans for various components such as housing, forestry, public spaces, and energy. It is clear we will need more elementary school space in 22202 and the County is already mulling a new high school. We have the perfect opportunity to create a vision that complements the investment of the universities and training centers in our zip code.

I have heard valid concerns about Amazon's impact, but I believe Amazon, JBG, and the County are making a good-faith effort to address some of those concerns. AHCA's job is to ensure continued engagement by those entities with our community. We are collaborating with the other civic associations in 22202 to do so and even though we are not all looking at the same playbook, public safety and education are shared priorities. We have everything Amazon wants in a community and if we work together we will all benefit from this transition.

I hope you will join us as we engage the various stakeholders. After all, we as residents are the most important stakeholders!

## Safety Improvements Planned for Arlington Ridge and Lang Street Slip Lane

To improve safety around school zones, a County project will close the southbound Lang Street slip lane in order to eliminate the conflicts between pedestrians and drivers. Other elements of the project include

wider sidewalks and a concrete median on Arlington Ridge. A study verified that closing this lane would not back up traffic. Construction is expected to occur in 2021.
