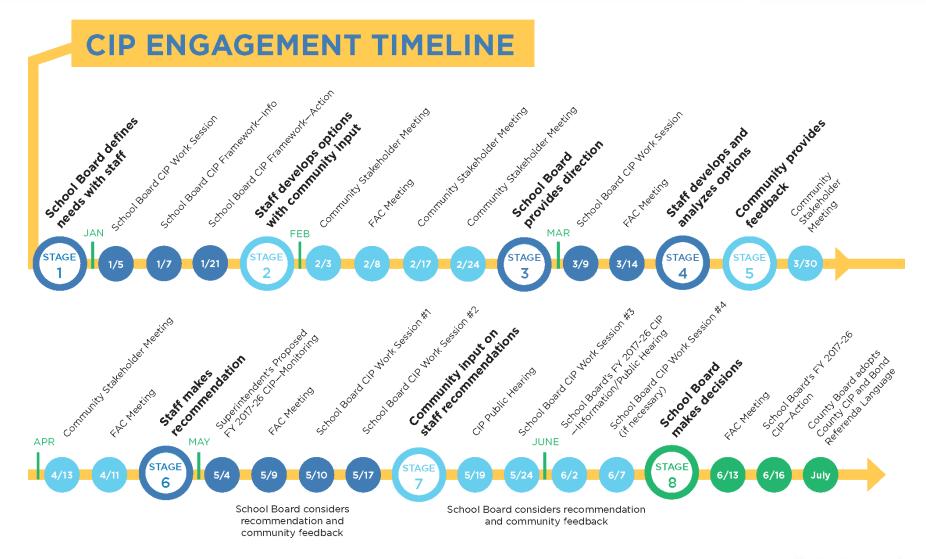

#### NOTE:

- 1,000 seats will be provided at the Stratford site when the middle school is completed; net seats added at the Stratford site will be approximately 334.
- If a capital project from a previous CIP has not started construction (i.e., Arlington Career Center), it will be re-evaluated in the next CIP based on changes in enrollment and
- 4 projections.



#### **Current Studies Supporting the CIP**



- Middle School Capacity Studies at Gunston, Kenmore & Williamsburg
- High School Capacity Studies at Wakefield & Yorktown
- Fenwick Transition to Secondary Space
- Recommendation to the School Board by March 17, 2016 regarding the move of Henry to the new site at Jefferson, the move of the Drew, Montessori Program to the Henry site, and the transition of Drew Model School to a standalone school.
- A report, based on 2016-2025 projections and additional CIP information, on options and next steps regarding the possibility of a new elementary school in the Pentagon City area post 2019. This report will be presented to the Board no later than April 1, 2016.







We must recognize that:

- APS cannot construct seats for all students projected within its debt capacity.
- APS must address most critical needs within its debt capacity.
- APS must make students and instruction first priority while also achieving greatest return on investment.

\* McKinley also has \$12.6M in bond funding from a previous CIP.

\*\* Abingdon includes HVAC, roofing, and infrastructure bond funding moved to the project.

Based on revisions and updates to the prior CIP:

- Required bond funding is \$38.2 million less.
- The highest debt service ratio is reduced from 9.96% to 9.51%.
- The cumulative debt service increase is reduced by \$3.8 million.



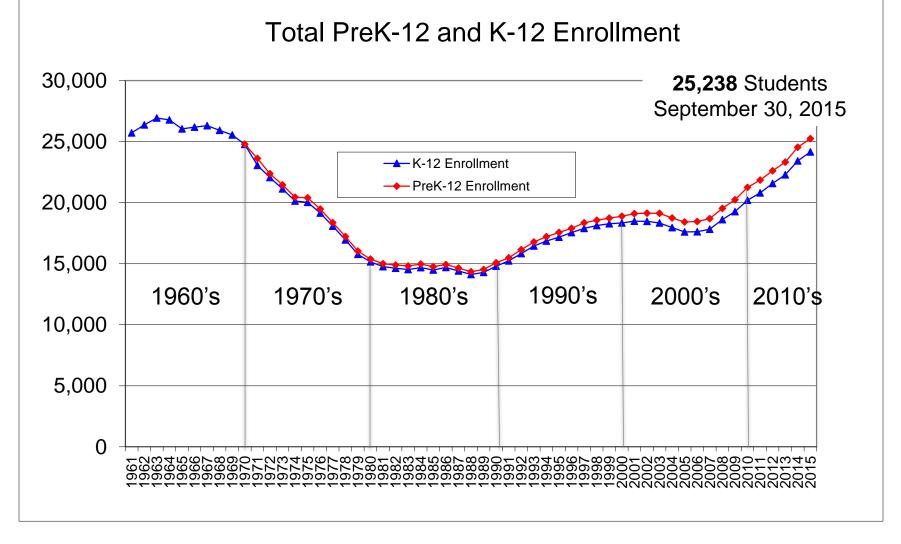
## **Enrollment Highlights**



- This year, enrollment increased by +709 students or 2.9% greater than the previous school year.
- Since School Year (SY) 2005-06, enrollment has grown +6,827 students or 37%.
- Between now and SY 2025-26, enrollment is projected to increase another +6,655 students or 26%.

Consider collaborating with county and external entities.

Consider internal space modifications.

Review previous direction to not build a new comprehensive high school.

Consider non-capital options.

Capital Options – permanent additions to APS assets that are funded through the capital budget.

#### Examples:

- Relocatables (purchased by APS)
- Minor construction/major maintenance
- Build additions to existing buildings
- Repurpose/reconstruct existing buildings
- Build new building on a new site





Non-Capital Options - increase the capacity of school buildings by maximizing the utilization of existing space. These options are not funded by the capital budget.

#### Some examples include:

- Increasing class size
- Adjusting class schedules
- Year round school model
- Expanding virtual class offerings

### **High School – Discussion Questions**

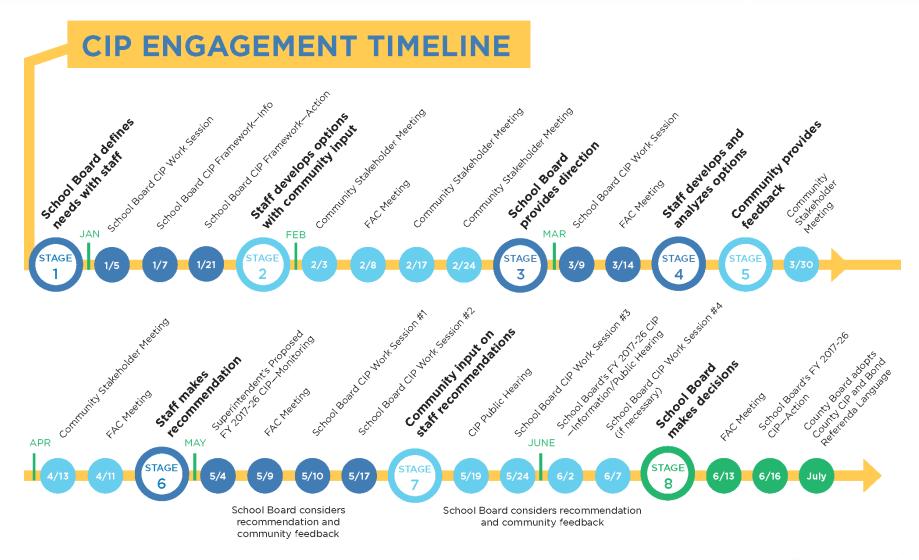


- Should the preferred maximum seating capacity at high schools be increased beyond 2,200?
