Crystal Substation Improvement and Expansion Project

AT DOMINION ENERGY, we would like to provide an update to the Crystal Substation Improvement and Expansion Project. On Nov. 14, 2020 we received Arlington County Board approval to construct the project. We invite you to learn more about the construction process, which is expected to begin in April 2021, at our upcoming virtual community meeting.

Our project team will provide an overview of what to expect throughout the construction process and answer any questions you may have. We will also provide an update to the public art installation and introduce our selected artist. WHAT:

This project involves making improvements to the existing substation and expanding the substation on a portion of the adjacent parcel, currently owned by Arlington County. In exchange for the adjacent parcel, Dominion **Energy will grant existing** property located at S. lves Street to Arlington County.

WHY:


AGING INFRASTRUCTURE — Much of the equipment inside the substation is approaching the end of its service life and needs to be replaced.

LOAD GROWTH – Additional infrastructure is required in order to continue serving the present load, meet the network reliability criteria, and prepare for anticipated load growth in the revitalized National Landing area.

SAFETY REGULATIONS - The existing substation needs physical improvements for safety and reliability of service. An increase in space will allow us to maneuver inside the substation to reach our equipment in a safe and efficient manner.


WHERE:

What is a substation?

A substation is a facility that changes voltage from high to low or from low to high using transformers. The lower voltage electricity is delivered to customers using electric distribution lines.
